STANDING ORDERS

1. MEETINGS OF COUNCIL AND RECORD OF ATTENDANCE

All meetings of the Council shall be held on the Wednesday after the third Saturday of each month at 7.30pm. Under special circumstances the Chairman shall have power to postpone the meeting. A record shall be kept of the attendance of members at each meeting.

2. NOTICES OF MOTION

Notices of all intended motions shall be given, in writing, to the Secretary not less than seven days before the meeting of Council. The Secretary shall place the motions on the agenda in the order received.

3. PROPOSALS AFFECTING RULES

All proposals of Committees and Members of Council involving any alteration of Rules shall be referred to the Rules Revisions Committee for their consideration before being adopted by Council.

4. ORDER OF PROCEEDINGS AT A COUNCIL MEETING

At each meeting of the Council the Secretary shall present the minutes of the last preceding Council Meeting. He shall read such letters as may be necessary.

The reports of Committees shall be next considered. The Chairman of each Committee shall propose the adoption of the report and members may then speak on any matter mentioned in the report, or move a resolution thereon.

The business on the agenda shall proceed within such order as the Chairman may direct.

5. MODE OF DISCUSSION

Each member, on speaking shall address himself to the Chairman. During the time any member is speaking, all other members shall respect this, unless another member raises a point of order through the Chairman. Whenever the Chairman occasions to speak, no one shall continue to speak or address the Chairman until the Chairman has concluded his speech.

6. MODE OF PROCEEDING ON A MOTION

All motions, whether original ones, or amendments, shall if the Chairman requests it, be put in writing, signed by the mover, and handed to the Secretary immediately on being moved, and members proposing such motions or amendments shall read the same before speaking on them.

7. RIGHT OF SPEAKING

The mover of every original resolution, but not of any amendment (unless it becomes an original motion) shall have the right to reply, not introducing therein any new matter, but confine himself strictly to the answering of previous statements, immediately after which the question shall be put from the Chair.

8. AMENDMENTS TO PROPOSITIONS

When an amendment is moved upon a proposition, a further amendment shall not be moved or taken into consideration until the first is disposed of, but any number of amendments may be brought forward in succession, and the question must be put in such a manner that if one amendment be negated, another may be moved upon the original proposition, but if the amendment be affirmed, it shall form the proposition under consideration, upon which further amendments may be moved. If after the disposal of an amendment, second or further amendments are not moved, the question must be ultimately be put upon the original or amended proposition as the case may be, to allow it to be passed as a resolution.

9. DISCUSSION UPON AMENDED PROPOSITIONS

When discussion arises upon an amended proposition, the mover of the amendment which has displaced the original proposition may speak in reply and so in like manner with respect to any further and displacing amendments.

10. MODE OF VOTING

All questions shall be determined by a show of hands unless afterward a formal division be demanded, or votes ordered to be recorded, which shall be done by any member, supported by at least two others. In that case, the names for and against shall be taken down by the Secretary and entered in the Minutes. In matters relating to elections, members may vote by ballot. In the event of a tie in the number of votes cast for and against a resolution, the Chairman of the meeting shall have a second (or casting) vote.

11. COMMITTEE OF THE WHOLE COUNCIL

The Council may, by vote, resolve itself into a Committee of the Whole Council, and whilst in Committee, there shall be no restriction as to the number of times a Member may speak to the question.

12. WHO MAY TAKE UP BUSINESS UNDER NOTICE

The business under any notice shall not (except by consent of the Council) be proceeded with in the absence of the member of Council in whose name it stands, unless he has given written authority for it to be taken up by another member.

13. OBJECTIONABLE BUSINESS

If the Chairman at any Council Meeting shall be in the opinion that any motion proposed to be made thereat is of an objectionable character, it shall be competent of him either before or after the same is brought forward, to put it to the vote, without discussion, whether the motion shall be entertained or not, and if two-thirds of the members present decide not to entertain such a motion, the same shall be considered disposed of for that day.

14. QUORUM NOT PRESENT (SEVEN)

Whenever during the transaction of business, it is stated to the Chairman that a quorum is not present, the Chairman, after verifying the statement shall declare the meeting at an end and the names of those present shall be recorded in the

15. STANDING COMMITTEES

The President and Secretary shall ex-officio be members of all Standing Committees of the Council.

Each Standing Committee shall support its own Chairman. Three members shall form a quorum.

All reports shall be presented to the Council, in writing, and after being read and adopted, a note of their reception shall be made in the minutes of the Council.

The following shall be Standing Committees of the Council:

Finance; Referees; Cup, Youth; Rules Revisions.

The members of Standing Committees shall continue in office until their successors are appointed.

16. POWERS AND DUTIES OF COMMITTEES

All Committees shall be deemed as Standing Committees of the Council and shall, as such meet as directed by Council who shall at that time specify their powers and duties in consideration of the business to be concluded. In special circumstances or in an emergency, the Chairman of Council may call a meeting of any Committee.

17. RESCINDING A RESOLUTION

A resolution may be rescinded at a meeting of the Council at which it has been passed, provided the motion to rescind shall be carried by two-thirds of the members present and voting.

18. PRIVILEGE

The discussion, statement of members, evidence of witnesses and other matters within and before the Council in Committee, and Committees shall be deemed privileged, and the Council shall have power to censure or suspend from service on the Council any member proved to be guilty of a breach of this.

The Council shall have the power to censure, suspend or remove from service on the Council any member whose conduct is deemed to be dishonourable or has been found in breach of the Rules of the Football Association

HEAVY WOOLLEN DISTRICT FOOTBALL ASSOCIATION

MEMORANDUM OF RULES, DUTIES AND PRIVILEGES

TITLE

1. The Association shall be called the ' Heavy Woollen District Football Association', and shall be affiliated with and directly under the control of the West Riding County Football Association Ltd.

AREA

2. The area of the Association shall be defined by the West Riding County Football Association Ltd and shall not be altered without the consent of the West Riding County Football Association.

CONSTITUTION

3. The Association shall consist of such Competitions and Clubs as the West Riding County Football Association Ltd shall approve.

GOVERNMENT

4(a). The Association shall be governed by a Council which shall be fixed at the Annual General Meeting.

4(b). The Council shall consist of a President (who shall be ex-officio on all Committees), Life Members (who shall have served 21 aggregate years on the Council), 13 District Representatives, Hon. Treasurer, Hon. Secretary, Hon. Minutes Secretary, any Vice President of the West Riding County Football Association resident in the area, League Representatives (on the basis of one representative for each 40 clubs or part thereof, being clubs affiliated through the Heavy Woollen District Football Association, two representatives being the maximum), and one representative from the Heavy Woollen Referees' Association.

The President, Chairman, Hon. Treasurer, Hon. Secretary, Hon. Minutes Secretary, and Sub Committees (to be defined) shall be elected by the Council at the first meeting after the Annual General Meeting. The President to be elected must have served three years on the Council. The Chairman elected shall retain office for no more than three consecutive years.

A Special Sub Committee may be appointed to elect members to Sub Committees.

District Representatives shall be elected at the Annual General Meeting each year as follows: two from each of the Districts of Batley, Morley and Ossett, three from the District of Spenborough and four from the District of Dewsbury, Mirfield and Heckmondwike.

Each member of the Council shall be furnished with a ticket (which shall not be transferable) and all Clubs, Leagues and Competitions shall admit the holder to their grounds and stands upon production of such ticket, without requiring any other authority, except on occasions when the Council shall decide otherwise.

4(c). All nominations shall be received by the Hon. Secretary on the forms provided, at least 21 days before the Annual General Meeting. Before any form be sent in, the consent of the persons) nominated must have been obtained. Any person nominating himself shall have such nomination declared void. Nomination forms shall only be supplied to Clubs who have paid their membership fee for the coming season and to Council Members on request.

4(d). In the event of any member of the Council other than Life Members being absent from three consecutive meetings without satisfactory explanation to the Council, his seat shall become vacant and the Council shall have the power to fill from the district any vacancy that may occur during the year.

4(e). The Council shall have power to co-opt such persons as it thinks fit to be a Council Member upon such terms and conditions as the Council may in its absolute discretion think fit. Such Council Members shall not be eligible to serve as Life Members.

REPRESENTATIVES TO THE WEST RIDING COUNTY FOOTBALL ASSOCIATION

5. The Association shall appoint one representative to the West Riding County Football Association for the first 100 (or part thereof) clubs in full membership under its jurisdiction and one representative of every additional 50 clubs or part thereof (representation to be calculated on the number of clubs having paid full affiliation fees for the previous season). Representatives shall be elected by the Council before the 31st July in each year.

DUTIES AND PRIVILEGES

6. The Association shall be responsible to the West Riding County Football Association for the actions of its clubs and players, officials and spectators, and shall take all precautions necessary, in conjunction with its clubs, to prevent spectators threatening or assaulting officials or players during or at the conclusion of matches.

The Association shall have power to control, conduct and manage its own approved competitions and see that all clubs conform to the Rules and Regulations of the Football Association.

The Association shall have power to suspend clubs for non-payment of fees, fines etc. in respect of its own Competitions.

All Clubs in the area covered by the Heavy Woollen District Football Association shall pay their Affiliation Fees to the West Riding County Football Association not later than 31st May in each year. Clubs who have teams playing both Saturday and Sunday must separately affiliate to the West Riding County Football Association.

A Club wishing to change its name must make application to the West Riding County Football Association. No Club can change its name during the season.

ANNUAL GENERAL MEETING

7. The Annual General Meeting shall be held not later than 31st July in each year at such a place that the Council shall appoint. Each Club having paid its affiliation fees to the respective County Association for the current season before the date of the Annual General Meeting shall be entitled to send one representative to this and all other General Meetings of the Association.

The Secretary of the Association shall give at least 14 days notice of the Annual General Meeting and the notice shall include any new nominations for Members of Council.

This meeting shall conclude the business of the previous season. The Council shall be entitled to vote at all Annual, General and Special Meetings. No two Clubs shall be represented by the same individual.

At the request, in writing, of a quarter of the Members of this Association, the Secretary of the Association shall call a Special General Meeting at ten days notice. An Extraordinary General Meeting may be convened by Council whenever it thinks fit.

DISPUTES

8. The representative of any Club or Competition concerned in a complaint, or in any dispute whatsoever, shall not be eligible to sit on the Council while the said complaint or dispute is being discussed.

RESPONSIBILITIES OF CLUBS

No player, or club, affiliated to their respective County Association shall be allowed to play in unaffiliated football. All players registered with Clubs affiliated to the West Riding County Football Association Ltd shall be placed at the disposal of the West Riding County Football Association Ltd for representative matches and Football Association Cup Competitions.

In cases of players who last played abroad, they must not take part in any matches for any Club at any level in this country until such time as clearance has been received by the Football Association from the National Association under whose jurisdiction the player last played.

It should also be noted that in the case of players who last played in Scotland, Wales and Northern Ireland it is still necessary for a clearance to be obtained from the appropriate National Association before the player can play for any Club in this country.

Failure to carry out the procedures will result in disciplinary action being taken by the appropriate County Association.

Any Club competing for a prize offered by any private individual or individuals, if the net proceeds do not go to some affiliated Football Club or Clubs, Charity or Charities, shall cease to be a member of the County Association unless the competing Clubs obtain the consent of their respective County Football Associations before playing for such a prize. .

No Club or player of any such Club shall take part in a football contest other than practice matches between teams of the same Club during the close season, except for Charities

10 (a). Every Club or Competition is responsible to the Council for the actions of its players, officials and spectators. Clubs and Competitions are further required to take all precautions necessary to prevent spectators threatening or assaulting officials or players during or at the conclusion of matches.

10 (b). Clubs changing their Secretary or ground, or Secretaries changing their addresses must notify the Secretary of the Association within 7 days. Clubs failing to comply with this rule will be fined the sum of £10. Misdirection of mail or opponents or

officials attending the wrong ground caused by failure to comply with this rule will not be accepted as an excuse in the event of other breaches of rule.

POWERS

11. The Officers of this Association shall be empowered to carry out the work of the Association until the Council is appointed.

The Council (or any Committee appointed by them to investigate and decide upon any matter) shall have power to punish any Club, Officials or Players of same, or members of the Council, by expulsion, fine or otherwise as they may think fit, should any of the parties enumerated above be found to be guilty of and breach of Rules of this Association, or the Football Association—but not for breach of the Laws of Association Football.

CALL ON CLUBS

13. The Council shall have first claim on the services of any player or official of the Heavy Woollen District Football Association for its official matches subject to the Football Association's order of precedence.

Any player selected to represent the Association will not be allowed to play for a club or representative team on the day of the game or during 48 hours prior to the date of the game. Players found to have breached this rule will be deemed to be guilty of misconduct and liable to suspension.

Any club or representative organisation proved to have encouraged or instigated such player to commit this offence shall be deemed guilty of misconduct and liable to suspension.

14. All Clubs affiliated to the West Riding County Football Association Ltd shall, if called upon, place their players and ground at the disposal of the Heavy Woollen District Football Association for one match a season; a minimum of 10 per cent of the proceeds less expenses shall be paid for the use of the ground if required.

MEMORANDUM OF RULES, DUTIES AND PRIVILEGES

15. All fines imposed by this Association must be paid within 14 days of receipt of the decision. Fines not paid by the due date will be doubled and if not then paid within 14 days of the date of the second notice, an administration charge of £25, Clubs in default may be struck out of all Competitions governed by this Association and its Committee and referred to the West Riding County Football Association to be dealt with as they may think fit.

In the event of cheques not being honored, an Administration Charge of £25 shall be made on the club concerned.

The Association shall have the power to suspend Clubs for non payment of monies which are owing to the Association.

APPEALS

16. Clubs, players and officials may appeal. The protest or appeal shall be in writing and shall be sent together with a Postal Order or Cheque for the amount as provided for by Rules 18 of the Cup Competition Rules, by Registered letter to the Secretary of the Association, so as to reach him within seven days of the date of the meeting or game in question and an exact copy of the same shall at the same time be sent by Registered letter to the individual Club or Competition against whom the appeal or protest is made.

The grounds of the appeal or protest shall be fully stated and in cases of an appeal or protest being improperly lodged, or deemed to be frivolous, the deposit may be forfeited. The Association shall have the power to compel any party to the complaint to pay such expense as may be deemed fit, or they may inflict such other punishment or fines as may be deemed fit. The Association may order any Club whose protest or appeal fails to pay the expenses of any such protest.

17. An appeal to the West Riding County Football Association Ltd against a decision of this Association shall be in accordance with Rule 5 of the West Riding County Football Association Ltd.

CUP COMPETITIONS

18. The Association shall have power to organise Cup Competitions approved by the West Riding County Football Association, subject to the Rules of the County Association. The Conference date for matches in such Competitions shall be the third Saturday or Sunday in each month.

All affiliated Clubs playing in the area covered by the Heavy Woollen District Football Association (except Clubs competing for the F.A. or County Cups) must enter the appropriate District Cup Competition, unless specially exempted by the Council of this Association, and must compete in accordance with these Rules and those of the Football Association. Applications for exemption shall be made to the Secretary of this Association, in writing not later than 31st May.

Matches that are ordered to be replayed must take place on the next Conference date or earlier by mutual agreement with the Leagues concerned.

All Semi-finals and Finals in any Competitions organised by this Association shall take preference at any time over all League and League Cup matches.

MINUTES

19. The minutes and proceedings of this Association shall be recorded for all meetings and submitted, if required to the West Riding County Football Association for confirmation.

FINANCES

20. The Income and Property of the Association shall be at their disposal, provided that such Income and Property shall be applied solely towards the promotion of the Objectives of the Football Association.

The funds of the Association shall be lodged with an approved Bank and/or Building Society in the name of the President or Chairman, Secretary and Treasurer. All accounts over £100 shall be submitted for the approval of Council before payment.

Two auditors shall be appointed annually. An audited Balance Sheet shall be sent to each Club at least 14 days before the Annual General Meeting of the Association. All trophies of the Association and such other effects or assets as may be acquired from time to time, shall be held in trust by the President and Treasurer of the Association, who shall for all intents and purposes be their legal owners.

Should the Association become defunct, then its surplus assets shall be applied to the West Riding County Football Association in liquidating the liability of the Association. If the surplus assets shall be more than sufficient to liquidate such liability, the balance shall be disposed of in accordance with Rule 8 of the Football Association's Regulations applying to Club Companies.

If such assets be insufficient to liquidate the Association's liabilities, then a levy shall be made on the Clubs in the area to produce a sum sufficient to do this.

RULES

21. A copy of the rules shall be submitted each season to the West Riding County Football Association for approval. The Association shall have power to add Rules applicable to the area, subject to the approval of the West Riding County Football Association.

22. In all other respects this Association shall be governed by the Rules of the West Riding County Football Association on points of issue.

23. Rule changes can only be made an Annual General Meeting or an Extraordinary Meeting called for the purpose and the same may be passed by a majority of not less than two-thirds of the members present and entitled to vote.

All notices of proposed alterations to the Rules of the Association by affiliated Clubs or Competitions must be forwarded in writing to the Secretary of the Association on or before the 31st December.

Any alterations to rules must be submitted to the West Riding County Football Association for confirmation.

24. The Association is entitled to receive each year from the West Riding County Football Association Ltd an appropriate proportion of its Clubs Affiliation Fees and its Referees Subscriptions.

BENEVOLENT FUND

25. The Heavy Woollen District Benevolent Fund shall be administered by the Council (or Sub-Committee if so decided) under the Benevolent Fund Rules.

HEAVY WOOLLEN DISTRICT FOOTBALL ASSOCIATION

WHEATLEY CUP COMPETITION (Saturday)

NAME

1. The Competitions shall be called the HEAVY WOOLLEN CHALLENGE CUPS and named the WHEATLEY CUP (for Saturday teams) and the BROOK BUTLER CUP (for Sunday teams). The President and Treasurer of the Heavy Woollen District Football Association shall be, for all intents and purposes, the legal owners of the Cups in trust for the Association.

CONTROL

2. The Council of the Heavy Woollen District Football Association, hereinafter called 'The Council' shall have entire control and management of the Competitions; they may however delegate their powers in part or in full to the Cup Committee in order to expedite decisions to ensure the progress of the Competition.

All participants shall abide by The Football Association Regulations for Safeguarding Children as determined by The Association from time to time.

ENTRIES AND FEES

3(a). All affiliated Clubs playing in the area covered by the Heavy Woollen District Football Association (except Clubs competing for the F.A. and County Cups) must enter the appropriate Competition unless specifically exempted by the Council, and must compete in accordance with these Rules and those of the Football Association. Applications for exemption shall be made to the Secretary, in writing, not later than May 31st.

3(b). Each Club competing per rule must forward to the Secretary of the Heavy Woollen District Football Association on or before 30th June, an Entrance Fee of £15. Clubs in default shall be fined £15 in addition to the Entrance Fee.

PLAYERS ELIGIBLE

4(a). To play in this competition, a player must have attained the age of 16.

No player shall be eligible to play for more than one competing Club. With the exception of the Semi-Final and Final Ties, each individual must have been a recognised playing member of the Club for which he proposes to play at least SEVEN days prior to the date fixed for the playing of the round, and only those players qualified to play in a round preceding the Semi-Final shall be eligible to play in the Semi-Final or Final.

A playing member is one who has actually played for the Club in the current season, or one who has been registered with the Club and has, in writing, intimated to the Secretary of this Association that he is a playing member of that Club. Signing a League Registration Form does not of itself qualify a player for this Competition. The Secretary shall in writing, acknowledge receipt of every such intimation.

In the case of postponed or replayed matches only those players shall be allowed to play who were eligible to play on the date fixed for the playing of the round. A Player qualified to play in any round shall be deemed qualified to play in any subsequent round by virtue of his original qualification.

A player who has been suspended may play in postponed or replayed cup ties after the term of his suspension has expired.

A player under written contract with a Club in the Competition shall be eligible to play for that Club only, provided his qualification is in accordance with the rule. No player under written contract shall be eligible to play in the Sunday Cup Competition.

4(b). When the Competitions are commenced in September and the League of which the Club is a member has not commenced its fixtures seven days prior to the third Saturday or the third Sunday in September, players registered with their League at least seven days prior to the date fixed for the playing of the September round will be understood to have otherwise qualified to play in such and subsequent rounds.

4(c). A Club shall play its full strength team in all ties with the exception of Clubs whose first team play in the County Cup. *No player shall be eligible who has made 8 or more combined appearances for a team that plays in a Contributory League or a higher League in the League or Cup competitions in which the club plays.* This rule also applies to players who are registered with more than one club in different Leagues.

Note: for the purpose of this Rule, being named as a substitute but not actually playing in the match does not count as an appearance

The Council shall have power to disqualify any competing Club who may be found guilty of any breach of these Rules or the Rules of the Football Association.

CLUBS TO PROVIDE LIST OF PLAYERS

5. The Secretary or appointed official of each team must supply the Secretary or appointed official of the opposing team, and the Referee, with a list of players' FULL NAMES and corresponding SHIRT NUMBERS of those taking part in the match (including substitutes) 15 minutes prior to the commencement of the game. Clubs failing in this respect shall be fined £10.

PARTICULARS TO CLUBS

6. The Club having choice of ground shall, at least five days prior to the date fixed for the match, notify the Secretary of the opposing Club, and the Referee and the Assistant Referees as to the best means of reaching the changing rooms and the ground and also the colours in which they intend to play. Clubs failing to comply with this rule shall be fined £10 for each offence.

Clubs in the Semi-Final and Final ties must notify the Secretary of the Association the colours in which they intend to play in such games at least seven days prior to the date fixed for the match. Clubs failing to comply with this Rule shall be fined £15.

SUBSTITUTES

7. A Club may at its discretion and in accordance with the Laws of Association Football use THREE substitute players in any match in this Competition who may be selected from FIVE players.

The names of the Substitutes must be given to the Referee in writing prior to the commencement of the match. Substitutes not so named may not take part in the match.

A player who has been named as a substitute but does not actually play in the game shall not be considered to be a player in that game within the meaning of Rule 4 of this Competition.

FAILURE TO PLAY

8(a). A Club failing to play in any tie without showing sufficient cause may be adjudicated to have been guilty of serious misconduct and may be liable to a fine not exceeding £500 and may be dealt with under Rule 9.

8(b). Any Club intending to withdraw must give information of their intention to do so in writing, to the Secretary of the opposing Club and to the Secretary of the Heavy Woollen District Football Association not less than fourteen clear days before the date fixed for playing, or will be reported to the Council who shall have power to compel such offending Club to pay the expenses incurred by their opponents, or take such action as they may deem expedient. If a Club desires to withdraw after a drawn game, intimation must be given, in writing to its opponents and the Secretary of this Association within 48 hours of the close of the match. Any Club withdrawing may be liable to a fine not exceeding £500.

8(c). A League match shall not be played in lieu of a Cup tie.

MISCONDUCT

9. The Council shall have power to deal with any competing Club, Player or Referee who may be proved guilty of any breach of the Rules of these Competitions.

CLUBS EXEMPT AND DRAW

10(a). The Council shall have power to exempt such Clubs as they may deem fit from taking part in the earlier rounds of the Competition.

10(b). The ties shall be drawn, the dates fixed and the matches played as the Council may determine, and immediately after each drawing, the Secretary of the Association shall intimate to each of the Clubs drawn the name of the Club against which it is drawn, and the date and the hour on which the tie is to be played.

Ties shall be played on the ground of the Club first drawn, except where the Council gives consent or orders the matches to be played on other grounds.

Where Clubs share grounds and are both drawn at home, the first drawn Club shall have preference.

Representatives of Clubs may be present when the ties are drawn. Clubs not receiving a copy of the draw within seven days of it being made shall notify the Secretary of the Association.

10(c). Clubs failing to acknowledge receipt of the draw within seven days from the date of issue will be liable to a fine of £10.

DURATION OF THE GAME

11(a). The duration of each match shall be 90 minutes in two equal halves of 45 minutes each. The referee shall allow for any time in each half in accordance with Law 7 of the Laws of Association Football. The interval at half time shall not exceed 15 minutes except by special permission of the Referee.

11(b). In the event of scores being equal after 90 minutes, extra time of 30 minutes in two equal halves of 15 minutes shall be played. If scores are still equal after the said extra time, the match shall be decided by the taking of penalty kicks in accordance with the procedure adopted by the International Football Association Board.

11(c). The Council shall have power to deal with any match which does not complete the required duration due to any cause whatsoever.

POSTPONED GAMES

12. With the exception of the Semi-Final and Final ties, postponed matches shall be arranged for the next Conference Date (the third Saturday or third Sunday in the following month) unless arrangements are otherwise made in conjunction with the Leagues in which the competing Clubs play.

GROUND

13. The dimensions and marking out of the ground shall be in accordance with Law 1 of the Laws of Association Football. Goal nets and corner posts must be provided and Clubs in default shall be liable to a fine of £10 for each offence.

GROUND FITNESS

14(a). The Referee appointed to a match shall be the sole judge as to the fitness of the ground on the day of the match unless the Local Authority has previously determined otherwise. The Referee is empowered to use his discretion to allow the start of a tie to be delayed where such a delay would allow the fitness of the ground to become acceptable. In such cases the competing Clubs must abide by his decision to delay the start or otherwise they may be dealt with under Rule 9.

In the event of the referee postponing the match, the home club must obtain the signature of the referee, who must also state his reason for postponement, on the form provided and this form must reach the Secretary of the Association NOT LATER THAN FIRST POST TUESDAY MORNING following the match. Clubs failing to comply with this rule shall be fined a maximum of £50.

14(b). If a referee postpones or abandons a match he must confirm his actions to the Secretary of the Association within 48 hours of the date of the match.

14(c). If a game is postponed and on the date scheduled for its re-arrangement, the field of the first team named is unavailable or unfit, that team must arrange an alternative ground or play the game on the ground of the second named team. Failure to comply with this rule shall result in the match being awarded to the non-offending team.

14(d). If the field of the first team named is unavailable on the original date for the match, that team must arrange an alternative ground or play the game on the ground of the second named team. Failure to comply with this rule shall result in the match being awarded to the non-offending team.

REFEREES AND ASSISTANT REFEREES

15(a). The Council shall appoint a Referee (and Assistant Referees in Semi-Final and Finals) to all matches in the Competitions. The Referee shall not be a member of either competing Club and his decisions on all questions of facts shall be final. All match officials appointed to these Competitions **must wear uniforms comprising of a plain shirt which shall be almost entirely black with a white or black collar and black shorts.**

15(b). In rounds prior to the Final, Referees shall be paid £22 in addition to travelling expenses. Assistant Referees and Fourth Officials where appointed, shall be paid £11 in addition to travelling expenses. In the Final, Referees, Assistant Referees and Fourth Officials shall receive a suitable memento. Officials travelling by car shall be entitled to charge 30p per mile expenses. Officials travelling by public transport shall be entitled to charge actual bus fares paid

15(c). Appointed Official(s) shall be entitled to charge half-fee and travelling expenses if they attend at the ground and the match is not played. If a match is not played through the fault of one of the competing Clubs, the appointed Official(s) shall be entitled to full fee and travelling expenses paid by the defaulting Club.

15(d). Where Official Assistant Referees are not appointed, each Club shall appoint a Club Assistant Referee whose duties shall be to signal when the whole of the ball has passed out of the field of play for a throw in and which team is entitled to the throw in. Clubs failing to do so will be liable to a fine of £10.

15(e). Where the appointed Referee fails to appear or is unable to continue, both Clubs MUST agree to a replacement Match Official (who may or may not be a Registered Referee and who may or not be a member of either competing Club). A Referee thus agreed upon for that game shall have the full powers, status and authority of a Registered Referee. Clubs failing to agree and thereby failing to play shall be liable to a fine not exceeding £100.

LATE STARTS

16. The Referee shall report all late starts. Clubs held responsible for late starts shall be fined **£10** for the first 10 minutes thereof and then 50p per minute thereafter. The Council shall deal separately with cases in which the start is delayed by more than 30 minutes.

RESULTS

17. The Secretary of each Club shall send, on the form provided, notice of the result, the full names of the players who played in the match (including substitutes) and the referees mark to the Secretary of the Association. The fully completed form shall reach him NOT LATER THAN FIRST POST TUESDAY MORNING following the match. Clubs failing to comply with this rule by the Secretary of the Association not receiving the form by the required date and/or him receiving an incomplete form at any time shall be fined £10.

Fines imposed for non receipt of the form or receipt of an incomplete form shall be paid within seven days of their imposition and payment shall be accompanied by a fully completed form. Failure to do so will result in the Council further dealing with the Club as they deem fit.

The Secretary of a Club marking the referee 60 or less must forward an explanation in writing and this must accompany the notice of the result. Clubs failing to comply with this part of the rule shall be fined £10.

PROTESTS AND OBJECTIONS

18(a). Protests and Objections relating to any violation of the Cup Rules or the Rules of the Association, must be lodged by the protesting Club with the Secretary of the

Association within 48 hours (Sundays not included) of the date of playing the tie or forfeited if the Council consider the protest trivial or groundless. Protests shall be which the protest or appeal arises, accompanied by a deposit of £25 which shall be made in writing and four copies sent to the Secretary of the Association by recorded Delivery and a copy to the Club protested against by Recorded Delivery.

18(b). All protests shall fully state the grounds on which it is founded.

18(c). Any objections relative to the ground, goal posts or bars, or other appurtenances of the game must be made to the Referee and Secretary or Captain of the opposing team before the time of the kick-off. If possible, the fault shall be remedied.

18(d). If the Council shall subsequently discover that any Rule has, in their opinion, been violated by mutual agreement between Clubs, or otherwise, it shall be in the power of the Council to disqualify any such Clubs from further competing in the ties, or to order the tie to be replayed and otherwise further deal with the offenders without any formal protest being laid.

18(e). The Council shall have the power to compel any protesting Club to pay such expenses of the Club protested against and the Club engaged in the protest to pay such sums as may be considered necessary towards defraying any expenses incurred.

18(f). Notwithstanding the above, the Council reserves the right to investigate any complaint regarding a breach of the rules of the competition and to deal with such matters as it deems appropriate.

18(g). No objection or protest shall be withdrawn, except by leave of the Council. In dealing with any protest, the Council may take into consideration the possession of any knowledge by the protesting Club which, if properly used, might have obviated the protest.

18(h). Clubs may appeal against decisions of the Council and must do so in accordance with the Rules of the West Riding County Football Association. The decision of the Appeals Board of the West Riding County Football Association shall be final and binding on all concerned.

ADMISSION CHARGES

19. The Council shall fix the charge for admission to the ground for Semi-Final and Final ties.

MATCH PROCEEDS

20. The proceeds of matches prior to the Semi-Finals shall be equally divided between the competing clubs, after paying thereout the advertising, police, referee and assistant referees and floodlighting expenses (maximum £20). Any loss is to be borne by the Home club. The Home club shall provide for the sale of tickets and the Visiting club for the checking of the same. The expenses of the sellers and checkers shall not be a charge on the gate. The gate receipts shall be approximately divided immediately after the match and a full statement and settlement shall be made within seven days of the match.

SEMI-FINAL AND FINAL PROCEEDS

21. Proceeds of Semi-Final and Final ties shall go to the funds of the Heavy Woollen District Football Association.

PROCEEDS FROM ORDERED REPLAYS

22. In any match ordered to be replayed in consequence of a breach of rule, the Club in default shall not receive and share of the proceeds of such replayed match without the consent of the Council. If consent not be given, the share shall be taken by the Association. If any loss shall occur in the replayed game, the same shall be borne by the defaulting Club.

NOTICES

23. All notices required by any of these Rules shall be addressed to the Secretary of the Association

TROPHIES AND MEMENTOS

24(a). When the winning Club shall have been determined the Cup shall be handed to the representative of such Club, which shall give an undertaking to return the Cup in a good and clean condition to the Secretary of this Association, not later than February 1st in the following year. Clubs failing to comply with this Rule shall be fined a sum not exceeding £100 and/or be liable to the full cost of repair or its replacement.

24(b). In addition to the Cup, the Association may present suitable mementoes to the players and substitutes of each competing Club in the Final tie.

24(c). When a player taking part is ordered to leave the field of play for misconduct, the memento to which he may be entitled may be withheld at the discretion of the Council.

COUNCIL POWERS

25(a). All questions of eligibility, qualification of competitors, interpretation of the Rules and/or Regulations as well as other matters in dispute shall be referred to the Council whose decision shall be final.

25(b). The Council shall have power, prior to the closing date for entry to the Competitions, alter or add to these Rules.

25(c). The Council shall have power to deal with any matter not provided for within these Rules.

25(d). The Council shall have power to double any fines for repeated offences.

CLUB COLOURS

26(a). Where the colours of the two competing Clubs are similar, the HOME Club must change, unless alternative arrangements are mutually agreed by the competing Clubs. Where this occurs in the Semi-Final or Final ties, both Clubs must change. The home team must notify the visiting team at least five days before the match the colours in which they will play. No player, including the goalkeeper, shall be permitted to wear black or very dark coloured shirts.

26(b). Players' shirts shall be numbered and the number on each player's shirt shall correspond with that on the team list and match result sheet. No two players shall have the same number. Failure to comply with this rule will result in a fine of £10.

26(c). Advertising worn on clothing must be in accordance with Football Association Rules and Regulations.

DECISIONS OF COUNCIL

(a). Expenses for clearing the ground of snow, and in other ways preparing the ground, must be borne by the Home club. Marking out of the ground is not a charge against the gate.

(b). A Club may, at its own expense, erect temporary stands, and take the proceeds where the opposing Club declines to join the expense of the erection. A temporary stand becomes a permanent one if used after the match for which it was erected.

(c). The Home club shall provide at least TWO footballs for the playing of any Cup ties and the same must be passed to by the Referee as suitable before the tie commences. Clubs failing to comply with this decision shall be fined £10.

(d). The Home club shall provide TWO Assistant Referees flags for the use of either officially appointed Assistant Referees or Club Assistant Referees as applicable. Clubs failing to comply with this decision shall be fined £10.

BROOK BUTLER CUP COMPETITION

THE RULES OF THIS COMPETITION SHALL BE THOSE APPLYING TO THE WHEATLEY CUP WITH THE FOLLOWING EXCEPTIONS:

4(a) (addition to last line of rule.....) No player under written contract shall be eligible to play in the Sunday Cup Competition.

4(c). A Club shall play its full strength team in all ties.

Note: for the purpose of this Rule, being named as a substitute but not actually playing in the match does not count as an appearance.

The Council shall have power to disqualify any competing Club who may be found guilty of any breach of these Rules or the Rules of the Football Association.

BLACKBURN CUP COMPETITION (Under 15)

THE RULES OF THIS COMPETITION SHALL BE THOSE APPLYING TO THE WHEATLEY CUP WITH THE FOLLOWING EXCEPTIONS:

NAME

1. The Competitions shall be called the HEAVY WOOLLEN CHALLENGE CUP and named the BLACKBURN CUP. The President and Treasurer of the Heavy Woollen District Football Association shall be, for all intents and purposes, the legal owners of the Cups in trust for the Association.

ENTRIES AND FEES

3(a). All affiliated Clubs playing in Under 15 football in the area covered by the Heavy Woollen District Football Association must enter the Competition unless specifically exempted by the Council, and must compete in accordance with these Rules and those of the Football Association. Applications for exemption shall be made to the Secretary, in writing, not later than May 31st.

3(b) A Club may, with permission enter a maximum of two teams in the provided that the Rules of the Competition are complied with.

3(c). Each Club competing per rule must forward to the Secretary of the Heavy Woollen District Football Association on or before June 30th, an Entrance Fee of £10 per team. Clubs in default shall be fined £10 in addition to the Entrance Fee.

PLAYERS ELIGIBLE

4(a). All players taking part in the Competition shall be non-contract players and shall have been over the age of 13 and under the age of 15 years of age **at midnight on August 31st** of the current season. In rounds prior to the Semi-Final, Birth Certificates, or other satisfactory proof of date of birth of each player taking part in the match must be produced by the Secretary of each competing Club to the Secretary of the opposing Club, prior to the commencement of each match. In Semi-Final and Final ties, such proof must also be supplied to the District F.A. member in charge. **In Semi Final tie and the Final tie, all team officials shall have current CRB ID Cards as per County FA Membership Rule No.1 which must be produced on demand.**

No player shall be eligible to play for more than one competing **team**. With the exception of the Semi-Final and Final Ties, each individual must have been a recognised playing member of the Club for which he proposes to play at least SEVEN days prior to the date fixed for the playing of the round, and only those players qualified to play in a round preceding the Semi-Final shall be eligible to play in the Semi-Final or Final.

A playing member is one who has actually played for the Club in the current season, or one who has been registered with the Club and has, in writing, intimated to the

Secretary of this Association that he is a playing member of that Club. Signing a League Registration Form does not of itself qualify a player for this Competition.

The Secretary shall in writing, acknowledge receipt of every such intimation. In the case of postponed or replayed matches only those players shall be allowed to play who were eligible to play on the date fixed for the playing of the round. A Player qualified to play in any round shall be deemed qualified to play in any subsequent round by virtue of his original qualification.

A player who has been suspended may play in postponed or replayed cup ties after the term of his suspension has expired.

A player under written contract with a Club in the Competition shall be eligible to play for that Club only, provided his qualification is in accordance with the rule. No player under written contract shall be eligible to play in the Blackburn Cup Competition.

4(c). A Club shall play its full strength team in all ties.

Note: for the purpose of this Rule, being named as a substitute but not actually playing in the match does not count as an appearance..

4(d). **Any Club which has 3 or more players selected for a County FA squad may apply for a particular match to be postponed.**

The Council shall have power to disqualify any competing Club who may be found guilty of any breach of these Rules or the Rules of the Football Association.

7. A Club may at its discretion and in accordance with the Laws of Association Football use THREE substitute players in any match in this Competition who may be selected from THREE players. *A player who has been substituted himself becomes a substitute and may replace another player at anytime subject to the substitution being carried out in accordance with Law 3 of the Laws of Association Football.*

The names of the THREE Substitutes must be given to the Referee in writing prior to the commencement of the match. Substitutes not so named may not take part in the match.

A player who has been named as a substitute but does not actually play in the game shall not be considered to be a player in that game within the meaning of Rule 4 of this Competition.

DURATION OF THE GAME

11(a). The duration of each match shall be 80 minutes in two equal halves of 40 minutes each. The referee shall allow for any time in each half in accordance with Law 7 of the Laws of Association Football. The interval at half time shall not exceed 15 minutes except by special permission of the Referee.

11(b). In the event of scores being equal after 80 minutes, extra time of 20 minutes in two equal halves of 10 minutes shall be played. If scores are still equal after the said extra time, the match shall be decided by the taking of penalty kicks in accordance with the procedure adopted by the International Football Association Board.

11(c). The Council shall have power to deal with any match which does not complete the required duration due to any cause whatsoever.

REFEREES AND ASSISTANT REFEREES

15(a). The Council shall appoint a Referee (and Assistant Referees in Semi-Final and Finals) to all matches in the Competitions. The Referee shall not be a member of either competing Club and his decisions on all questions of facts shall be final. All match officials appointed to these Competitions shall be required to wear the traditional black shirts with white collar and cuffs, black shorts and black stockings with white turnover tops.

15(b). In rounds prior to the Final, Referees shall be paid £15 in addition to travelling expenses. Assistant Referees and Fourth Officials where appointed, shall be paid £7.50 in addition to travelling expenses. **In the Final, Referees, Assistant Referees and Fourth Officials shall receive a suitable memento. Officials travelling by car shall be entitled to charge 30p per mile expenses. Officials travelling by public transport shall be entitled to charge actual bus fares paid.**

15(c). Appointed Official(s) shall be entitled to charge half-fee and travelling expenses if they attend at the ground and the match is not played. If a match is not played through the fault of one of the competing Clubs, the appointed Official(s) shall be entitled to full fee and travelling expenses paid by the defaulting Club.

15(d). Where Official Assistant Referees are not appointed, each Club shall appoint a Club Assistant Referee whose duties shall be to signal when the whole of the ball has passed out of the field of play for a throw in and which team is entitled to the throw in. Clubs failing to do so will be liable to a fine of £10.

15(e). Where the appointed Referee fails to appear or is unable to continue, both Clubs MUST agree to a replacement Match Official (who may or may not be a Registered Referee and may or may not be a member of either competing Club). A Referee thus agreed upon for that game shall have the full powers, status and authority of a Registered Referee. Clubs failing to agree and thereby failing to play shall be liable to a fine not exceeding £100.

SECKER CUP COMPETITION (Under 13)

THE RULES OF THIS COMPETITION SHALL BE THOSE APPLYING TO THE BLACKBURN CUP (Under 15) WITH THE FOLLOWING EXCEPTIONS:

NAME

1. The Competitions shall be called the HEAVY WOOLLEN CHALLENGE CUP and named the SECKER CUP. The President and Treasurer of the Heavy Woollen District Football Association shall be, for all intents and purposes, the legal owners of the Cups in trust for the Association.

ENTRIES AND FEES

3(a). All affiliated Clubs playing in Under 13 football in the area covered by the Heavy Woollen District Football Association must enter the Competition unless specifically exempted by the Council, and must compete in accordance with these Rules and those of the Football Association. Applications for exemption shall be made to the Secretary, in writing, not later than May 31st.

PLAYERS ELIGIBLE

4(a). All players taking part in the Competition shall be non-contract players and shall have been over the age of 11 and under the age of 13 years of age **at midnight on August 31st** of the current season. In rounds prior to the Semi-Final, Birth Certificates, or other satisfactory proof of date of birth of each player taking part in the match must be produced by the Secretary of each competing Club to the Secretary of the opposing Club, prior to the commencement of each match. In Semi-Final and Final ties, such proof must also be supplied to the District F.A. member in charge.

DURATION OF THE GAME

11(a). The duration of each match shall be 70 minutes in two equal halves of 35 minutes each. The referee shall allow for any time in each half in accordance with Law 7 of the Laws of Association Football. The interval at half time shall not exceed 15 minutes except by special permission of the Referee.

11(b). In the event of scores being equal after 70 minutes, extra time of 20 minutes in two equal halves of 10 minutes shall be played. If scores are still equal after the said extra time, the match shall be decided by the taking of penalty kicks in accordance with the procedure adopted by the International Football Association Board.

11(c) For all matches in this competition a size 4 ball shall be used

11(d) The minimum size of goal posts in this competition shall be 7 yards wide 7 feet high.

WHEATLEY CUP COMPETITION (Saturday) BROOK BUTLER CUP (Sunday) BLACKBURN CUP COMPETITION (Under 15) SECKER CUP COMPETITION (Under 13)

Your attention is drawn to the following directive issued by the Council of the Heavy Woollen District Football Association.

It details instructions relating to the number of persons allowed in the 'dug- out/technical areas' at District Cup semi-finals and finals.

1. The only persons allowed in the dug-out/technical area are **a maximum of five substitutes and three other persons** who may be the Secretary, Trainer, Coach or any other nominated person.
2. All persons in the dug-out/technical area must remain seated at all times where such provisions are provided and in any case must not encroach within one metre of the touch line.
3. All other persons connected with the club or otherwise must remain outside the barrier surrounding the field of play.
4. The name of a person who shall be responsible for ensuring this directive is carried out must be given to and identified to the 'Council Member in Charge' and to the referee and his assistants not less than 30 minutes prior to the commencement of the game.
5. The referee and his assistants (and fourth official where appointed) shall at all times take the appropriate action in accordance with the Laws of Association Football to ensure that the points made in sections 1, 2 and 3 are enforced. He shall also report to the Association any club that fails to comply with section 4.

SAFEGUARDING CHILDREN

Note: 'The Association' refers to the 'Football Association'

1. Any act, statement, conduct or other matter which harms a child or children, or poses or may pose a risk of harm to a child or children, shall constitute behaviour which is improper and brings the game into disrepute.
2. In these Regulations the expression of 'Offence' shall mean anyone or more of the offences contained in Schedule 1 of the Children and Young Persons Act 1933 and any other criminal offence which reasonably causes the Association to believe that the person accused of the offence poses or may pose a risk of harm to a child or children.
3. Upon receipt by the Association of:
 - 3.1 notification that an individual had been charged with an offence; or
 - 3.2 notification that an individual is the subject of an investigation, by the police, Social Services or any other authority relating to an Offence; or
 - 3.3 any other information which causes the Association reasonably to believe that a person poses or may pose a risk of harm to a child or children, then the Association shall have the power to order that the Individual be suspended from all or any specific football activity for such period and on such terms as it thinks fit.

In reaching its determination as to whether an order under Regulation 3 should be made the Association shall give consideration, inter alia, to the following factors:

- 4.1 whether a child is or children are or may be at risk from harm;
 - 4.2 whether the matters are of a serious nature;
 - 4.3 whether an order is necessary or desirable to allow the conduct of any investigation by the Association or any body to proceed unimpeded.
5. The period of an order referred to in 3 above shall not be capable of lasting beyond the date upon which any charge under the rules of the Association or any Offence is decided or brought to an end.
 6. Where an order is imposed on an individual under Regulation 3 above, the Association shall bring and conclude any proceedings under the Rules of the Association against the person relating to the matters as soon as reasonably practicable.

Where a person is convicted, or is made the subject of a caution in respect of an Offence, that shall constitute a breach of the Rules of the Association and the Association shall have the power to order the suspension of the person from all or any specific football activity for such a period (including indefinitely) and on such terms and conditions as it thinks fit.

8. For the purpose of these Regulations, the Association shall act through its Council or any Committee or Sub-Committee thereof, including the Board.
9. Notification in writing of an order referred to above shall be given to the person concerned and/or any club with which he/she is associated as soon as reasonably practicable

HEAVY WOOLLEN DISTRICT FOOTBALL ASSOCIATION

BENEVOLENT FUND RULES

1. The object of the fund is to grant assistance, at the sole discretion of the Association, to players and others directly connected with affiliated bodies or within the jurisdiction of the association who may be injured whilst playing football or who may be incapacitated through illness directly attributed to participation in the game and who really need such assistance. Grants may be also made to necessitous persons who have rendered service to the game in the district or to their dependants, subject in each instance to the approval of the Council (or such sub-committee expressly appointed). Grants from the fund to Charitable and Benevolent Institutions and objects in alignment with aims and purposes of the Association may be made if, in the Committee's opinion, including the state of the fund, should warrant.
2. The fund shall be administered by a Controlling Committee appointed by the Council of the Association, and the controlling authority shall be responsible to the Council of the Association for the administration and application of the fund in conformity with these rules.
3. Application must be made on a form to be obtained from the Secretary of the Association. No form shall be accepted unless it gives all the information required thereon, is signed by the applicant, certified by the Chairman and Secretary of the Club or Competition with which the applicant is connected and accompanied by a Medical Certificate. Applications by amateur players or by Clubs on the latter's behalf will be governed by the consideration that it will be the incumbent on the officials to see that the total amount of benefit from all sources, including any grant from the fund does not exceed the player's actual financial loss as specified in the Rules of the Football Association. The form shall then be returned to the Secretary of the Association who, subject to the approval of the Chairman and/or other deputed authority, shall make the payment recommended. A grant may be made in the form of (a) a lump sum or (b) a series of weekly or periodical payments to be paid out by a member of Council or other authorised person. All grants shall be periodically reported through the controlling body to the Council of the Association.
4. The fund is established not to supersede efforts by the Clubs and others interested in the case, but to supplement these local efforts and any other source of income that may be available to the applicant during or in respect of his incapacity from work.
5. No salary or honoraria shall be paid from the fund for service in its control or administration, and all costs incurred in the control or administration of the fund shall be paid from the General account of the Association.
6. The fund shall be maintained in an account separate from the General Fund of the Association and if invested, in whole or in part, shall be placed in Trustee Stock or a form investment of sound and recognised security. Loans for any purpose whatsoever from the fund shall not be made to Associations, Leagues or Clubs.

7. Unless there are exceptional circumstances grants shall only be made to members of Competitions, Clubs etc. which have contributed to the fund during the current or immediate past season.

8. Each affiliated Competition, Club, Official or Referee is eligible to contribute to the fund in some form or other, for example, (a) the proceeds of practice matches, (b) the gate receipts of at least one match, (c) a personal subscription from Competition or Club funds or a grant from the balance of funds of a charity competition, (d) one or more collections at home matches each season or (e) donations by referees of at least one match fee during each season. The fund shall not incur any liability to the Association, but the Council shall have power to make a grant to the fund at the end of any financial year, to arrange a match or matches for the benefit of the fund and to invite private subscriptions or donations.

NOTE: It is a principle of a Football Benevolent Fund that it is based on voluntary contributions because no individual can then claim, as a right, any benefit; it must be benevolence.
