QUALIFICATION OF PLAYERS IN DIVISION 2 OR LOWER
 Rule 8 (C) A Team in Division 2 or lower may not include any player who has taken part in more than six matches for a Club that is not a member of this League, but is registered with the appropriate County Association as having Senior Status during the current season. For the purpose of this Competition a Senior Competition is a Competition that is sanctioned at Step 5 or above by the National League System.

➤ This registration process requires **1 passport style photograph** of the player to be uploaded to FA WGS.
 ➤ Where a player is under age of eighteen years, it shall also be a condition of registration that a fully completed and signed Parent / Guardian consent form (downloadable from league website) must be added to the online registration form.
 ➤ A new photo and player registration form is required for a transfer and a £10 transfer fee payable to the league.
 ➤ **FALTURE TO COMPLY WILL LEAD TO THE FORM BEING REJECTED AND THE PLAYER NOT BEING REGISTERED**
